Statement

I confirm that I and my party have read the conditions listed below and I personally take responsibility for compliance with the conditions.

1. We will leave the house in a reasonably clean and tidy condition at the end of the stay. We undertake to bear the costs of any excess cleaning.
2. We will replace any damages or inform and reimburse the owner for any damage to the building, furniture, bedding, carpets and other contents.
3. We will use the accommodation solely for its purpose as holiday accommodation.
4. We absolve the owner of any responsibility for accident, illness, injury or losses sustained while on the premises however caused.
5. We will limit occupants to those detailed on the booking form.
6. We will not bring pets into the property.

7. While in the property we will not smoke cigarettes, cigars or pipes and will not use candles except in emergency.

8. Any disputes or claims will be settled if possible by arbitration and under English law.

9. The booking is made on the understanding that, if accepted, the property will be made available to us for the period indicated. However, the owners cannot accept responsibility for unavailability of the property due to circumstances beyond their control other than to refund prepaid rental in respect of the time that the property is unavailable.

10. CANCELLATION: If we have to cancel our reservation we will inform the owners as soon as possible. If we cancel with at least 8 weeks notice, we will receive all prepaid money less a charge of £10. With notice of between 6 and 8 weeks we will be charged 25% of the booking value. With notice of between 4 and 6 weeks we will be charged 50% and with less than 4 weeks notice we will be charged 75%.
